Lack of Social Media expertise amongst SG members. ML offered to investigate Face book Technical Aspects of Consultation Process Uncertainty about how many comments might be received-Arlesey only had ~40. There will be less comments if parishioners satisfied with the Plan. Two options to retrieve comments back: 1) SB/JP have researched BRCC help-Jemma Maclean can set up Survey Monkey, with necessary hyperlinks, also could crunch data if necessary. Cost is budgeted for in Groundwork grant. However, Jemma only works Mon/Tues, cannot set up final survey until NP policies are approved at NPC (in case of any changes required eg with AECOM).
